- Note flow direction of filter.
- _ For quick connect fittings, push scratch free tube end into the fitting until it bottoms. **Threaded fittings must be wrapped with Teflon_ tape before installation.** Install Teflon_ taped fittings and tighten firm. Use two wrenches to firmly tighten tubing.
- _ Flush new cartridge with 5 gallons of water prior to use and check for leaks. If leaks occur, check tightness of tubing and fittings. If leaks persist, discontinue use and call your supporting dealer.
- Replace cartridge when rated capacity (1,500 gallons) is reached, or when flow becomes too slow.
- _ Install in compliance with state and local laws and regulations.
